

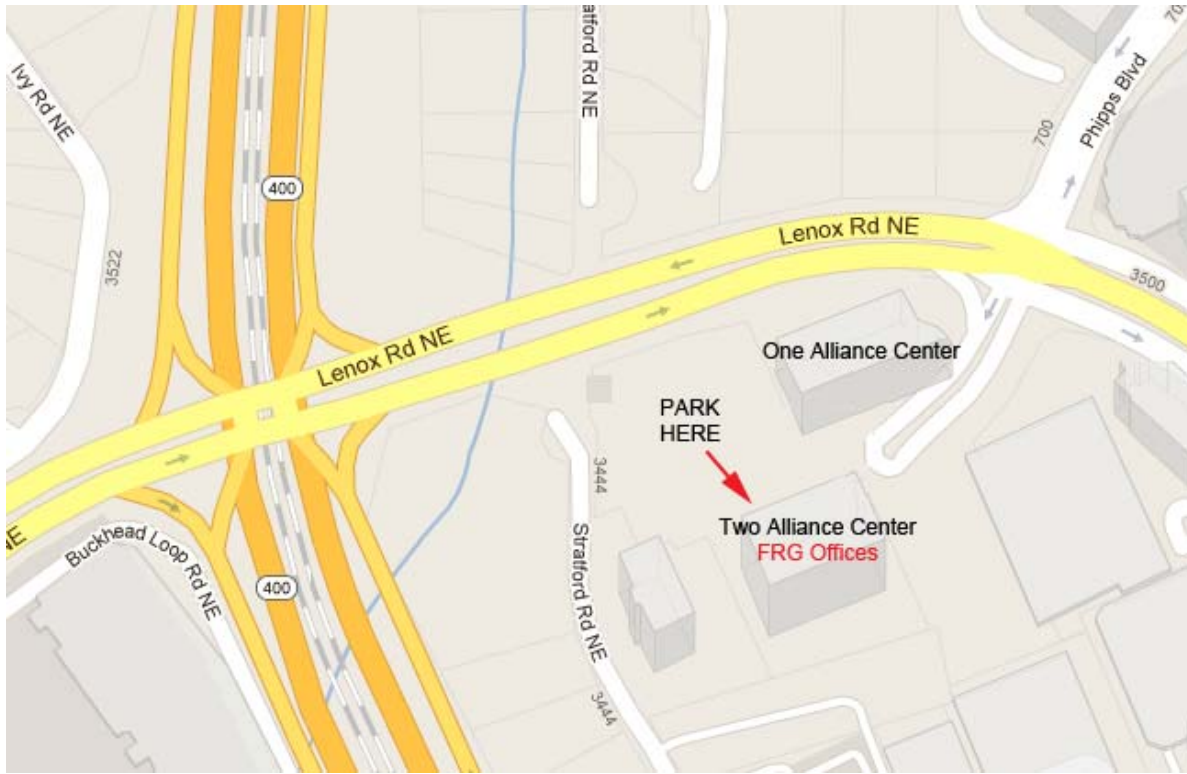

DRIVING DIRECTIONS



from South Atlanta

Take I-75/85 North through downtown Atlanta. Continue on I-85 North at the Brookwood split and take Exit 87 on to Georgia 400 North. Continue to Exit 2, Lenox Road/Buckhead. Take a right onto Lenox Road and continue in the right-hand lane. Take a right at the first light, which is the entrance to the Alliance Center complex. Continue going straight until you see the entrance to the Two Alliance parking garage on your left. Visitor parking is located on level P5. When you enter the lobby at P5, continue to the main elevators. We are located on the twelfth floor, Suite 1250.

from North Atlanta - Georgia 400

Take Georgia 400 South to Exit 2, Lenox Road/Buckhead, the first exit after the toll booth inside I-285. Turn left onto Lenox Road and continue in the far right-hand lane. Take a right at the first light, which is the entrance to the Alliance Center complex. Continue going straight until you see the entrance to the Two Alliance parking garage on your left. Visitor parking is located on level P5. When you enter the lobby at P5, continue to the main elevators. We are located on the twelfth floor, Suite 1250.

from Northwest Atlanta - Cobb County

Take I-75 South to I-285 East, Exit 259A. Continue on I-285 East to Exit 27 for Georgia 400 South. Exit Georgia 400 at Exit 2, Lenox Road/Buckhead, the first exit after the toll booth inside I-285. Turn left onto Lenox Road and continue in the far right-hand lane. Take a right at the first light, which is the entrance to the Alliance Center complex. Continue going straight until you see the entrance to the Two Alliance parking garage on your left. Visitor parking is located on level P5. When you enter the lobby at P5, continue to the main elevators. We are located on the twelfth floor, Suite 1250.

from Northeast Atlanta - Gwinnett County

Follow 85 South inside the perimeter to Exit 88, Cheshire Bridge Road/Lenox Road/GA-400 North. Turn right on Lenox Road and then left at the first light onto Buford Highway. Stay in the right-hand lane and turn right onto Sidney Marcus Boulevard. Take the next right to the entrance for Georgia 400 North. Continue to Exit 2, Lenox Road/Buckhead. Take a right onto Lenox Road and continue in the right-hand lane. Take a right at the first light, which is the entrance to the Alliance Center complex. Continue going straight until you see the entrance to the Two Alliance parking garage on your left. Visitor parking is located on level P5. When you enter the lobby at P5, continue to the main elevators. We are located on the twelfth floor, Suite 1250.

from East Atlanta
